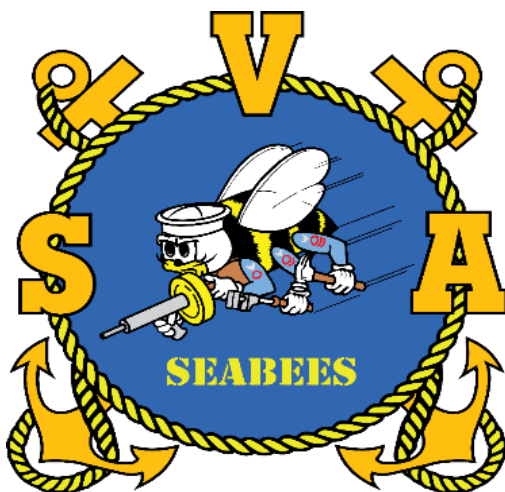

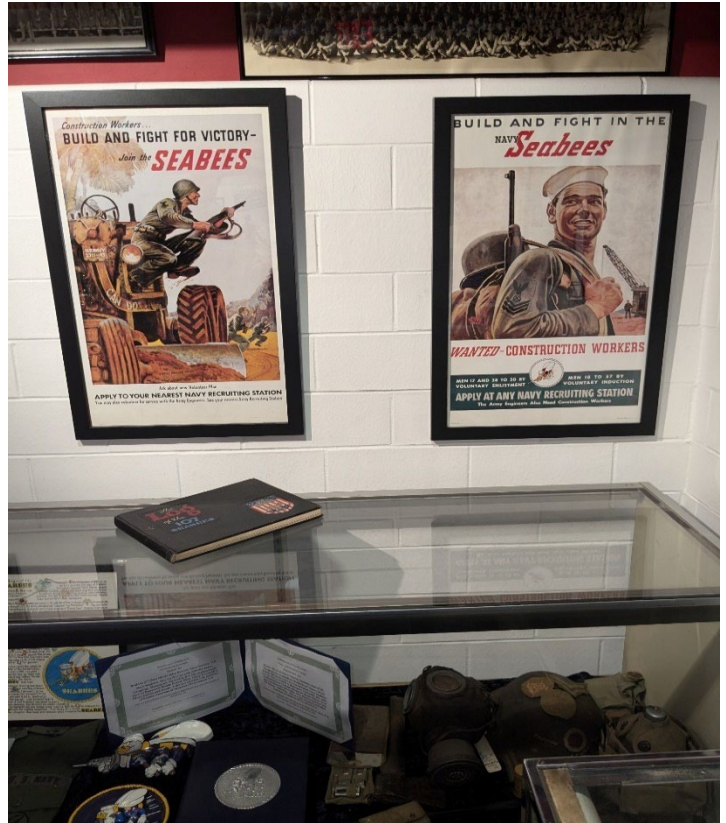

We were also pleased to have a number of former and current Navy Seabees in the capacity audience for Johnson's presentation (picture below). Thanks to everyone who came out for this special night!



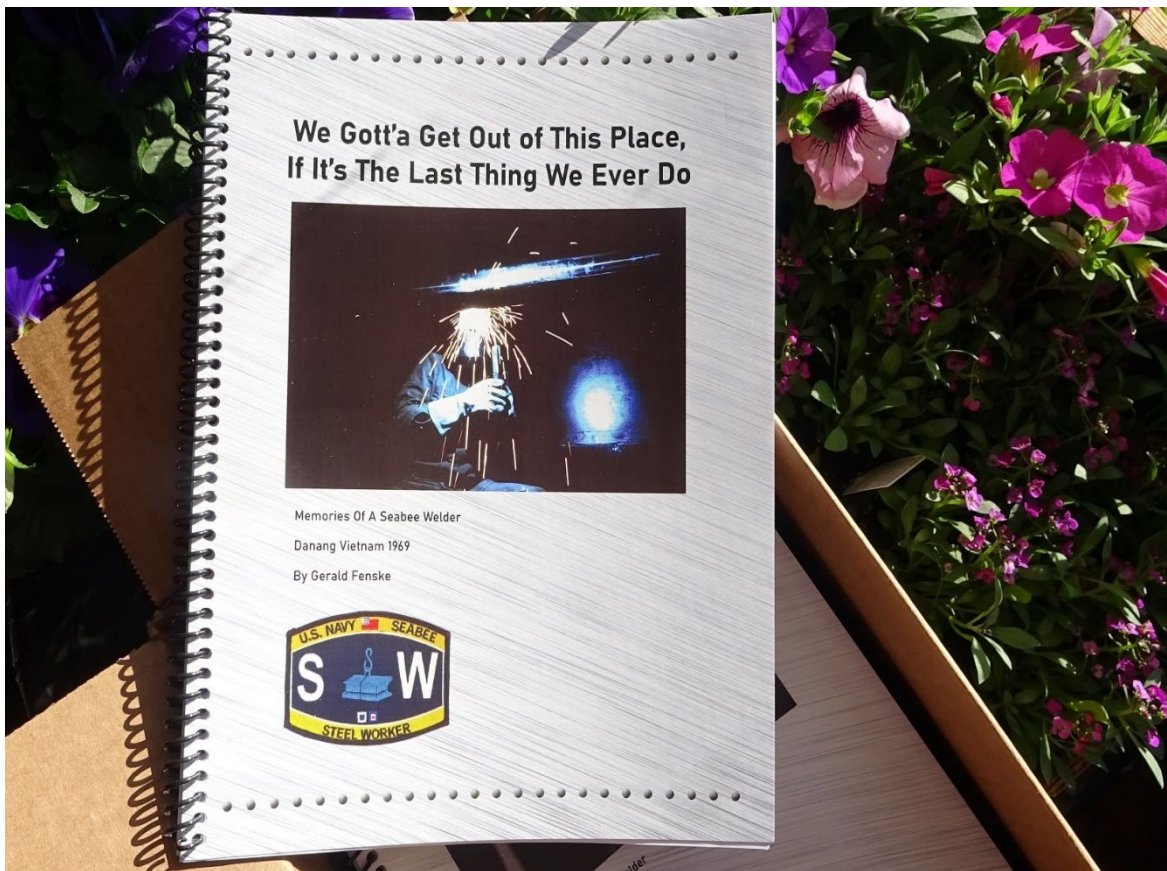

CELEBRATING A CENTURY
The Remarkable Journey of WWII Pacific Seabee Antonio "Tony" Fonseca

As the sun rose on October 19, 2024, family and friends gathered to celebrate a momentous occasion: the 100th birthday of Antonio "Tony" Fonseca, a true American hero. With a lifetime of stories etched in his heart, Tony reminisced about his extraordinary journey as a Navy Seabee during World War II, a journey that spanned continents and defined his character.

From City Streets to War-Torn Shores



Tony's adventure began on August 31, 1943, when he enlisted in the Navy Seabees a unique branch of the military known for both building and battling. Reporting to 383 Madison Avenue in New York City, he was just a young man ready to serve his country. "I was proud to wear that uniform," Tony recalled, his eyes sparkling with nostalgia. "Little did I know the challenges and friendships that awaited me." After boot camp at Camp Peary in Virginia and further training at Camp Endicott in Rhode Island, Tony embarked on a convoy aboard the SS Cape Bon. His mission? Building and maintaining the critical infrastructure needed to support Allied operations across the Pacific.

Facing Danger Head-On



Tony's journey took him through the Panama Canal and across the Pacific, arriving in Milne Bay, New Guinea, in February 1944. It was here that the realities of war hit home. "We faced air raids and danger daily," Tony recalled somberly. "But we were there to build roads and bases, to support our troops. We had a mission. Among his vivid memories is a close call during a Japanese air raid, where shrapnel narrowly missed him. "It was terrifying, but those moments brought us closer together," he reflected. "We became a family."

From Builders to Celebrators

While the war was filled with hardship, there were also moments of joy and adventure. Tony chuckled as he recalled sneaking off for liberty in Australia. "I just had to see the sights! It was a once-in-a-lifetime chance." His laughter filled the room, a testament to the resilience and spirit that characterized his service. As the war came to an end on August 14, 1945, the joy was palpable. "We heard the sirens and ran to celebrate," Tony said with a grin. "The bar closed ten minutes later, but what a night it was!"



A Legacy of Strength and Hope



Today, Tony stands as a beacon of strength and hope. His journey through the Pacific, marked by danger and bravery, shaped not only his life but the lives of countless others. Reflecting on his service, he humbly remarked, "I consider myself lucky. I came home and built a family." As friends and family raised their glasses in a heartfelt toast during his birthday celebration, they honored not just Tony's incredible life but the spirit of resilience and camaraderie that defines the Seabees.

"Here's to you, Tony!" they cheer, celebrating a legacy that continues to inspire.

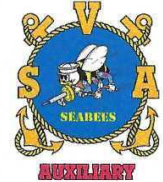

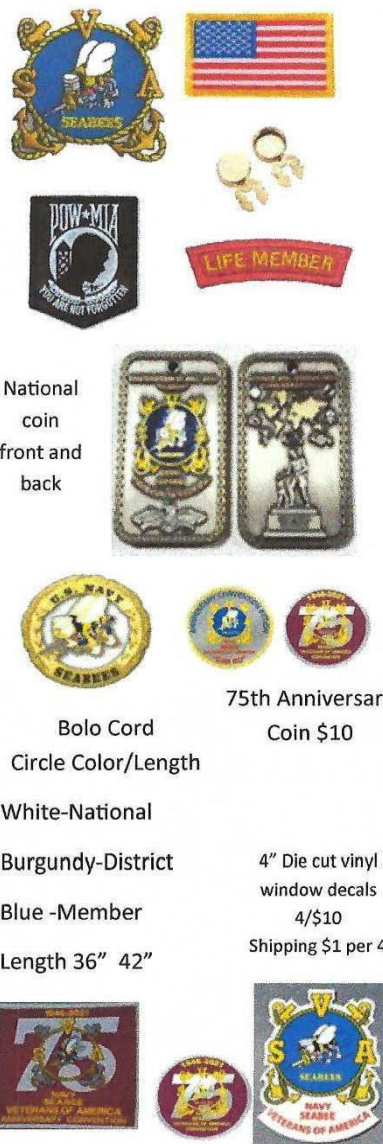
